He regularly counsels Austria's largest bank in international litigation and served as board chairman of its U.S. subsidiary. He acts for Austria's largest electricity and power enterprise and one of its largest realtors, and has represented other major European companies.

Charles also represents the American Federation of Teachers and has served as lead negotiator for municipal labor unions, including the United Federation of Teachers and the Patrolmen's Benevolent Association. He has been appointed by federal courts to serve as a special master to resolve complex disputes, including ERISA, securities and antitrust matters, and has served as a private arbitrator and mediator in a variety of contexts.

Charles has extensive public sector experience. He serves as a board member of New York's Metropolitan Transportation Authority, including Metro North Railroad, Long Island Railroad, NYC Transit Authority and Triborough Bridge & Tunnel Authority; as a member of the Board of Directors of the New York City Housing Development Corp.; and has served on the board of the Dormitory Authority of the State of New York. He was Commissioner of Housing and Buildings of the City of New York; a real estate and development consultant to New York City Mayor John Lindsay; a member of the city's Air Pollution Control Board; and chairman and commissioner of the New York State Insurance Fund.
